- 一、 選修本系為輔系而未修過心理學者，需補修普通心理學（一）三學分或普通心理學（二）三學分，其中擇一（兩門科目無次序性），且不得列入輔修規定之 25 學分。
- 二、 選修本系為輔系者，輔系科目中若已為其原學系之必修或必選者，不必再修，但不能抵免，得由系主任指定本系相關課程代替。
- 三、 選讀本系為輔系者需修習至少 25 學分，其中系訂必選修九學分，整合選修六學分。

1.Students who did not pass the Psychology course need to re-take the 3 course credits either Introduction to Psychology I or Introduction to Psychology II course and cannot to count toward the minor regulation of 25 course credits.

2.Students need not re-take any required course(s) of their home department that are listed in this course outline; such course(s) cannot be waived. The department chair will designate a relative course(s) to substitute for that.

3.Students need to take at least 25 course credits, in which 9 required course credits and 6 electives for three groups course credits.
